I, further, on behalf of my heirs, executors, administrators, and assigns release and indemnify the University from any and all causes of actions, and further waive any and all claims against the University occurring to myself as a result of participating, engaging in, playing in, observing, traveling to any University from any and all causes of actions, and further waive any and all claims against the University form any and all causes of actions, and further waive any and all claims against the University occurring to myself as a result of participating, engaging in, playing in, observing, traveling to any University Sports.

2. Photographic or Video Image/Likeness Release. I hereby grant permission to the University (as referenced in paragraph 1.) to photograph or videotape in any media my image, likeness, or depiction and further to edit, crop, or retouch such photographs or digital images, and waive any right to inspect the final photographs or images. I hereby consent to and permit the photographs or images of me to be used by the University worldwide for any purpose, including educational and advertisement purposes, and in any medium, including print and electronic and waive any right, interest, claim for compensation, claim for damages and cause of action regarding the University's use and/or editing of such photograph, videotape or digital image.
